Routes to show

From north - Take 294 south to Irving Park Rd. West exit. Get into left lane immediately and turn left (south) at first stoplight - Mannheim Rd. Take Mannheim south 2 blocks to United Parkway (light). Turn right (west) and follow United Parkway around to 4233. Park in back of building or on one side of street.

From south - Take 294 north to Interstate 90 - O'Hare exit to Mannheim Rd. south exit. Take Mannheim south to United Parkway. Follow above from there.
