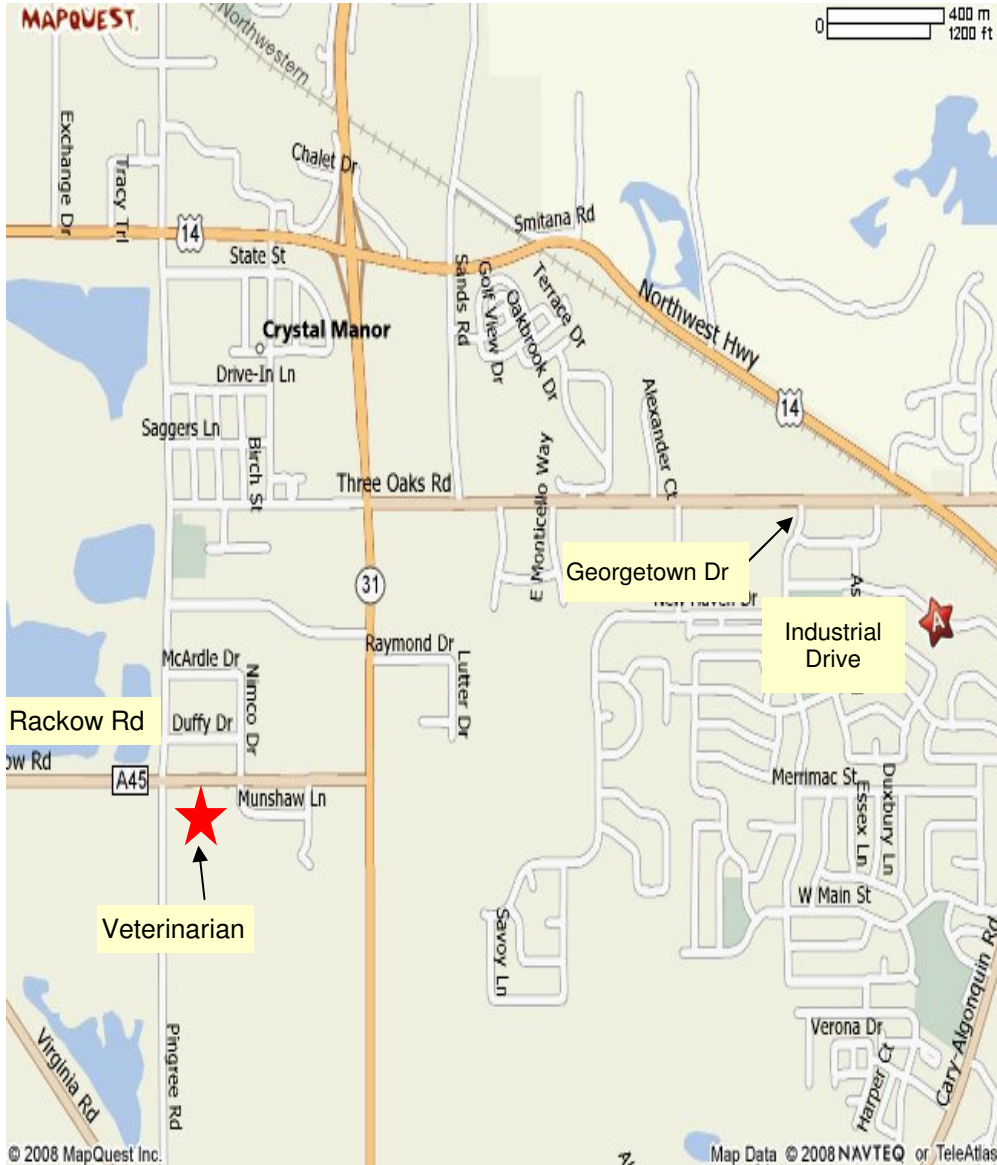

## ROUTES TO SHOW

**FROM THE NORTH:** Route 31 south to Three Oaks Road. Turn East (LEFT) on Three Oaks Road to Georgetown Dr., Turn RIGHT

**FROM THE SOUTH:** I-355 North to Lake-Cook Road. Exit west for 5 miles to Route 14 (Northwest Highway). Turn Right. Proceed 8.5 miles to Three Oaks Road, Turn Left two blocks to Georgetown Dr. Turn LEFT

**FROM THE EAST OR WEST ON I-90** to Route 31 North 13 miles to Three Oaks Road. Turn East (RIGHT) on Three Oaks Road to Georgetown Dr. Turn RIGHT

**FROM GEORGETOWN DRIVE** go two blocks to Industrial Dr., Turn Left, proceed 1/2 mile on Industrial Dr. Northwest Obedience club is on your right just before Federal Express.
