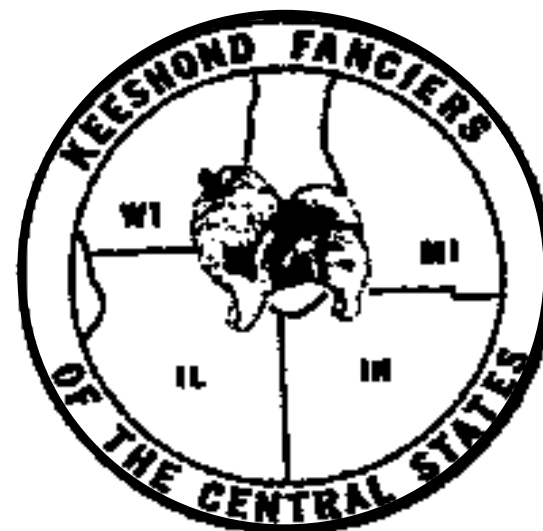
Turn Right (north) Go 2.1 miles to Production Dr., Turn Left onto Industrial Dr. which turns into Dunham to 530 Dunham Rd.
